**Memorandum of Understanding for opening
Learner Support Centre / Study Centre for Under
Graduate and Post-Graduate (Non-lab) Programmes of
Netaji Subhas Open University**

In terms of Netaji Subhas Open University First Statutes (Revised), 2014 No. 8(4) and No. 24(5) and in tune with the UGC (ODL programmes & Online Programmes) Regulations, 2020, this Memorandum of Understanding (MOU) is being signed between the University and the host Institution where the Learner Support Centre (LSC)/ Study Centre is housed.

In full appreciation of the aims and objectives of the University as well as its operational principles, the undersigned as the Head of

West Bengal

puts on record the consent of the authorities of the Institution to house a Learner Support Centre(LSCs)/Study Centre (herein after the Centre) of the Netaji Subhas Open University (herein after the University or NSOU as it is commonly known) under the following terms and conditions:

J. K. Parichha

- i) to make available for the said purpose necessary infrastructure such as two rooms each of size at least 600 sq ft. and provide services for efficient running of the Centre, including receiving of study materials from the University and distribution of the same to individual student;
- ii) To provide the class rooms/ seminar room as per requirements of the teaching-learning processes.
- iii) to comply with the Rules and Regulations, which are already in force and/ or which to be introduced by the University &/or the UGC-Distance Education Bureau (DEB) &/or other statutory body(ies) as may be applicable, in respect of LSCs / Study Centres from time to time;
- iv) to run the Post Graduate LSCs / Study Centres offering Arts, Commerce & Mathematics only out of the share amount received from the University in this regard as per the norms of the University which are in force and which may be promulgated from time to time.
- v) to maintain complete records of:-
 - (a) all expenses including those incurred out of the amount received by the LSC/ Study Centre,
 - (b) student enrolment, renewal and assessment in different subjects,
 - (c) academic and supportive staff working at the LSC/ Study Centre and
 - (d) all programmes of the LSC/ Study Centre;
- vi) to conduct examinations as and when required, in consonance with the schedule announced by the University;
- vii) to send regular reports to Director, Study Centres and/or other concerned officers of the University regarding the activities, needs and progress of the LSC/ Study Centre and to allow visiting teams consisting of University authorities and/ or any person who may be authorized by the University for monitoring purposes.
- viii) All teachers (including SACT-I) of LSCs have to participate in any academic activities as and when instructed by the University.
- ix) To engage coordinator along with other supporting staff following the G.B. (of the College/HEI concerned) resolution under intimation to the Director, Study Centres, NSOU.
- x) It would be the responsibility of all academic counsellors attached to the LSC/ Study Centre to participate in the teaching-learning and evaluation process of NSOU viz., Personal Contact Programme (PCP) and evaluation of answer papers of the Term-End and Assignment Examinations as may be assigned to them from time to time by the concerned authority of the college/ LSC/ Study Centre and/or NSOU.
- xi) LSCs/Study Centres will have to conduct laboratory based activities /field work/dissertation/hands on training (as would be applicable) for the enrolled learners of the University as and when instructed by the University.
- xii) The Principal/Teacher-in-Charge/Officer-in-Charge and Coordinator shall abide by the provisions of the relevant sections of NSOU Statutes /Law/Regulations and other directions which may be relevant for the purpose of the smooth running of the LSCs / Study Centres.

- xiii) LSCs / Study Centres shall create a TAB in the college Website for NSOU to give all information relating to the University. All the notices and schedules relating to Admission, Renewal, Personal Contact Programme, Examinations etc will be uploaded on the relevant link (TAB) of the college website.
- xiv) The Learner Support Centre/ Study Centre will put a notice board and signboard depicting the University name and logo at a distinct place in the college premises in order to make the same visible.
- xv) It shall be the responsibility of the LSC/ Study Centres to submit the Audit Report of the grants received by them by 31st May each year.
- xvi) Programme Offered : Vide Annexure (the programmes offered by the university to the LSC/Study Centre are provided in the annexure herein and shall be treated as the part and parcel of this agreement).
- xvii) The LSCs/study centre will organize Induction Meeting before the commencement of each academic session with newly admitted students. University officials (faculties/officer) may participate in the programme whenever necessary on invitation.
- xviii) The LSCs/ study centre should strictly follow the normal working hours which are as follows::
- Saturday (2pm to 5pm); Sunday (10.30am to 5.30pm)
- xix) The college/Higher Education Institution will not open more than two LSCs of two different Universities including NSOU. And it shall be the duty of the college to inform the NSOU if and when the second LSC is opened and put to function.
- xx) Neither Party will be liable for any failure or delay in performing an obligation under this Agreement that is due to any of the following causes (which events and/or circumstances are hereinafter referred to as "Force Majeure"), to the extent beyond its reasonable control: acts of God, accident, riots, war, terrorist act, epidemic, pandemic, quarantine, civil commotion, breakdown of communication facilities, breakdown of web host, breakdown of internet service provider, natural catastrophes, governmental acts or omissions, alteration, variation and repeal in laws or regulations that are in force, national strikes, fire, explosion, generalized lack of availability of raw materials or energy; provided that the parties stipulate that Force Majeure shall not include the novel coronavirus Covid-19 pandemic which is ongoing as of the date of the execution of this agreement.

For the avoidance of doubt, Force Majeure shall not include:-

- (a) financial distress nor the inability of either party to make a profit or avoid a financial loss,
- (b) changes in the market prices or conditions, or
- (c) a party's financial inability to perform its obligations hereunder.

This Force Majeure Clause applies for parties entering into the instant contract in the midst of the ongoing Covid-19 pandemic, and with restrictions imposed by the appropriate government which want to ensure that current existing circumstances at the time of execution of this agreement and/ or MOU are not considered Force Majeure events.


- xxi) In case of any litigation the High Court of Calcutta, should be the authority.

- xxii) The Clauses on Termination of this instant agreement shall be made on mutually agreed conditions subject to the protection of learners' interest and without causing any prejudice to them who are already enrolled.
- xxiii) This MOU is subject to further revision, if any, when the Regulations of the University comes into force.

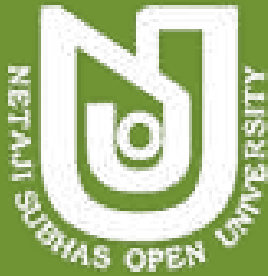

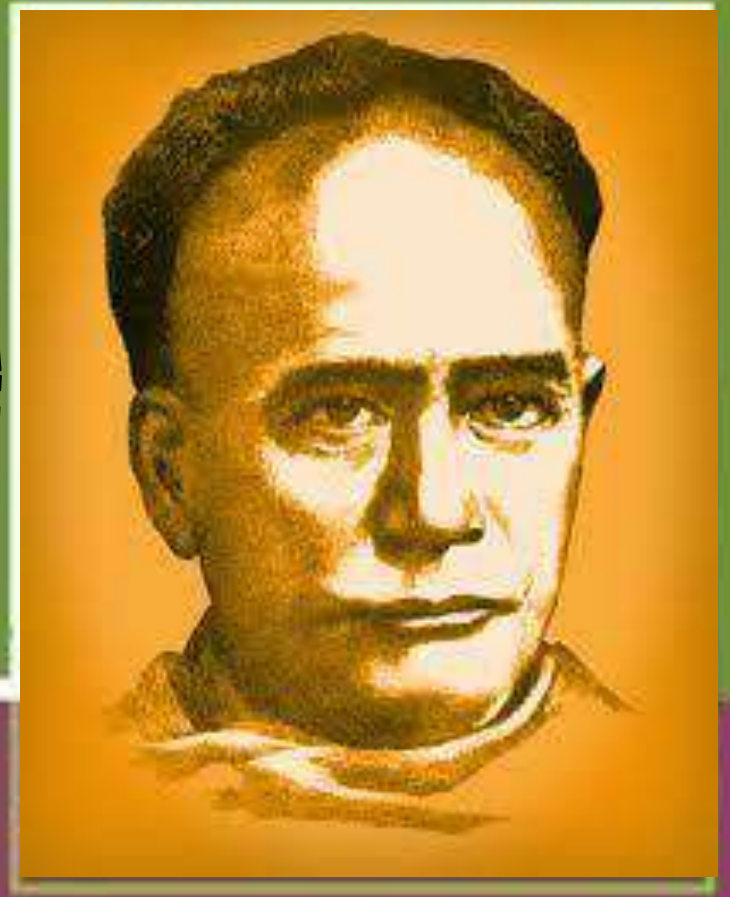

Suri Vidyasagar College was established in the year 1942 at the initiative of some great educationists as a branch of Vidyasagar College, Calcutta. Education at the then Vidyasagar College of Calcutta was severely hindered by the socio-political turmoil prevailing throughout India during and after the World War II. On the one hand, there was a pressing need to shift Vidyasagar College from Calcutta to a safer location outside Calcutta and on the other hand, there was a great demand among the education-loving people of Suri and its surrounding areas to set up a degree college at Suri, the headquarter of the district of Birbhum.

On 9th March, 1942, under the stable and foresighted chairmanship of an alumnus of Calcutta Vidyasagar College--Shri. Abinash Chandra Mitra, the college started its auspicious journey as a branch of Vidyasagar College, Calcutta. In course of time this branch was nurtured by so many dedicated academicians of the time with great care and devotion. As a result, after 1948, it with its inherent strength and vivacity could emerge as an independent college with the name **Suri Vidyasagar College**. The first Principal of the Suri Vidyasagar College was Prof. Arun Sen who led the college in the direction of steady progress in terms of curricular, co-curricular and extra-curricular activities from 1951 to 1963.

The college was previously affiliated under The University of Calcutta from 1942 to 1960 and thereafter it got its affiliation under The University of Burdwan and got UGC recognition under 2f with effect from January 1, 1968 (Sl. No. 602). This College boasts of several Luminaries as its alumni. Since its inception, the College has produced students who have gone on to become leaders and visionaries in their respective field. The long list includes Vice Chancellors, Director of IIT, Scientists of International repute, Film maker, Judge, Eminent political personalities, etc. It is a matter of great pride that this College counts Late Pranab Mukherjee, The Honourable former President of India as one of her Alumnus.

At present, in 2015, the college stands tall, spreading the message of knowledge and wisdom to the society at large keeping pace with the changes taking place in the socio- academic world. Currently, it spreads over an area of 25 *Bighas*, 5

Kathas and 8 *chataks*, the college consists of 20 (twenty) Academic Departments of Studies and 1 (one) P.G. Course (within the Zoology Department). In 1996, the total built area of the college was 29,856 sq. ft. Another 14,755.31 sq. ft. was added between 2001 and 2004. Currently the total built area is around 70,000 sq. ft. which contains Classrooms, Laboratories, Staff Rooms, Rest Rooms, Storage, IQAC Office, Language Laboratory, Library, Office, Seminar Halls, Canteen, Bank, Post Office and Students' Hostel (separate for boys and girls).

Opening of the Study Centre

The Study centre was approved by the University in January 1998 with first twenty two study centers in West Bengal.

The memorandum of understanding (M.O.U.) was signed by Dr. S.P.Ghosh, the then Teacher-in-charge of Suri Vidyasagar College on 18.01.1998 with proper consent of the Governing Body of the College.

Academic session of the study centre started from July 1998 with 14 admitted students. This is the first batch of the study centre and also the first batch of the university.

The number of enrolled students enhanced from semester to semester. Now the study centre is on a position of honour with respect to the roll strength and results of the students.

The NAAC Peer Team visited our College for the 1st Cycle of Accreditation in November, 2005 and awarded with B+ grade in the year 2006. And in 2nd Cycle of Accreditation in 2016 and awarded with B++ grade.

RESPONSIBILITY OF THE UNIVERSITY:

- A) Development of the course curriculum.
- B) Preparation of Self Instructional Materials (SIMs): The University will take the responsibility for the preparation of quality SIMs by competent resource persons and for printing and despatching of the same to the Study Centre.
- C) Advertisement: Advertisement for admission and related publicity in the media / website will be the sole responsibility of the University.
- D) Admission Form and Prospectus: The admission forms and prospectus will be generated through online system and other relevant materials will be supplied through the University to the Study Centre.
- E) Administration of Examinations: The University will administer all examinations which will involve:
- Question paper setting;
 - Printing and despatching the same to the respective examination centres;
 - Printing and despatching answer scripts and loose sheets to the Study Centre;
 - Evaluation of answer scripts;
 - Preparation of transcripts and issuing certificates to the students through the Study Centre.
 - **Fees of repeat or backlog candidates:**
Rupees 500/- (Five Hundred) is to be paid to the study centre by every backlog or repeat candidate [for entire part or semester examination] as examination fees and this is considered effective from 2023-2024 academic session.
- F) A monitoring Committee, duly constituted by the University Authorities, will supervise the Study Centre from time to time. Observations and suggestions of the committee regarding the quality of teaching, learner's support service etc. will be given due emphasis at the both ends. The Study Centre will agree to accept and implement any or all the recommendations whenever made by such a committee for maintaining the required academic standards and assuring the quality of the programmes.

RESPONSIBILITY OF THE STUDY CENTRE:

The Study Centre shall provide academic and administrative support services to the distance-learners.

Role and functions of the Study Centre:

1. The Study Centre will be responsible for giving information (by e-mails/SMS/web notification/by post) to the students about the programmes.
2. Arranging admission of students as per norms and conditions to be specified by the University.
3. To distribute Enrolment Cards, to be generated through online system by the DDE, B.U./Study Centre, amongst the students.
4. To collect filled in registration forms / restoration forms from the students and send these to the DDE, B.U.
5. Arranging continuous assessment of students' progress in studies by competent academics under norms and conditions to be specified by the University.
6. The Study Centre shall maintain a library for candidates enrolled under the distance mode. Measures will be taken to make reading room facilities available to the students. Books may be lent out to students on deposit of caution money or the price of book(s).
7. Arranging Counselling and Personal Contact Programmes (PCPs).
8. The Study Centre would send the list of eligible teachers to the DDE for approval by the competent authority of the University before engaging them as resource persons for Counselling and PCPs.
9. The Study Centre will conduct the examinations under norms and conditions to be specified by the University. The Study Centre will make all necessary arrangements including proper invigilation. The expenditure to be incurred in connection therewith will be met from the examination fees to be collected from the students.
10. The Study Centre would prepare the list of eligible teachers who would be entrusted with the task of assessing answer scripts and sending the same to the Controller of Examinations, B.U. These enlisted teachers would mainly examine answer scripts of the candidates appearing at Burdwan Centre. On the other hand, answer scripts of the candidates appearing at the Study Centre would be assessed by the examiners selected by the Department of Controller of Examinations, B.U.
- 11. The center will take necessary measures to send the answer scripts of the examinees of the study center in a sealed packet to the Burdwan University CDOE office within 7 days of the completion of the examination (part or semester).**

12. The Principal/Teacher-in-charge/ Officer-in-charge of the college, in capacity of the Study Centre-in-charge, one co-ordinator, one assistant co-ordinator and two staff members (having sufficient computer knowledge) will be entitled to a monthly honorarium to be paid out of the share of the course fees of the Study centre concerned as follows (if fund permits):

*Study Centre in Charge = Rs. 2500/- , Co-ordinator = Rs. 2500/- ,
Asst. Co-ordinator = Rs. 1500/- and Staff members = Rs. 500/- each.
Otherwise as per decision of the G.B. of the college.*

INTAKE OF THE STUDENTS:

For distance education programme there may not, as such, be any restriction on the number of students to be admitted. However, intake of a particular programme will depend on the overall resource and infrastructural facilities available in the Study Centre and on the capacity of the centre to conduct the examinations.

SHARING OF THE REVENUE:

The course fee realized by the Study Centre from the candidates enrolled under it will be shared by the University and the Study Centre at a 70:30 ratio in that order. After completion of the process of collection of fees the University will release the share of the Study Centre through account payee cheque or through demand draft whichever is convenient, within a period of 60 days. The course fee sharing scheme would be reviewed in future on the basis of exigency of the situation. As for the examination fees, these will be retained by the University and the Study Centre will be paid centre fee for conducting examinations.

STUDENTS SUPPORT SERVICES:

The Study Centre on the suggestions and the recommendations of the University will provide all kinds of student-support services. The total hour of counselling and PCPs and other teaching aids will be specified by the University. It will be responsibility of the Study Centre to ensure optimum satisfaction to the students in their pursuit of the courses for which they are enrolled. For all such support services the students will not be charged any additional fees beyond the course fee and the examination fee.

Sponsored) (here in after abbreviated as SVC and referred as party I) (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in office, representatives, administrators, and assigns) agrees to assist **Dr. Goutam Bit, S/O Late Rabilochan Bit**, the Principal, Bejoy Narayan Mahavidyalaya (Government Sponsored) (here in after abbreviated as BNMV and referred to as party II) (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in office, representatives, administrators, and assigns) to carry out academic and research activities in SVC end and whereas the Principal of BNMV will reciprocate the same academic criteria.

The academic criteria include (a) Faculty Exchange Program (b) Hiring expertise examiner/moderator/reviewers for UG and PG as and where applicable (c) Conducting joint research in the fields of interest to both the parties, (d) Organisation of joint scientific activities (e) Access to the instruments and equipment, and software available in both institutes as and when applicable (f) Organisation of various student participatory programs like the workshop, seminar, symposium, internship, short-term Diploma, Certificate courses.

2. General Terms and Conditions of MOU:

- (i) Duration of MOU: This MOU shall be operational upon signing and will have an initial duration of Five years (05 yrs). All activities conducted before this date within the vision of the collaboration will be deemed to fit under this MOU.
- (ii) Coordination: To carry out and fulfill the aims and scopes of this MOU, both institutes will nominate the Head of the Department (HOD) or authorized Person as a Representative of any committee, as and when required.
- (iii) Termination of MOU: The partnership covered by this MOU shall in general terminate upon completion of the agreed schedule i.e., 5 yrs. However, this Memorandum may be terminated with three month written notice from either end of two parties
- (iv) Extension of Agreement: The MOU may be extended by the Heads of the participatory institutions if they agreed to do so.

Exchange students will be responsible for ensuring their own transportation arranged either individually or by the home institute, and the host institute is neither liable to give travel expenses to them nor responsible for providing financial aid for any purpose to an exchange student. It is the responsibility of the exchange students to secure their own housing accommodations, if required, however, on request of the particular student; the host institute may provide assistance in locating appropriate housing facility. Though our proposed collaborative project in the year 2019 was jeopardised for the pandemic, but with easing out the initial two stages of the pandemic and following rolling out of vaccines, we can expect normalcy in coming months.

This is to resume our discussion about digitisation project in near future without changing any terms and conditions as laid in the draft MoU in early 2020, a copy of the same is enclosed for your kind perusal.

Terms of agreement on proposed collaborative project of retrieval through digitization of newspapers available at the library of the Suri Vidyasagar College, Suri

- The project aimed at digital preservation of the entire run of *Birbhum Barta* available at the library of the Suri Vidyasagar College, Siuri, Birbhum.
- The newspaper is an important document of regional nationalism and culture of the Birbhum district and now it is possibly available only at the library of the Suri Vidyasagar College that is too in an unusable condition. In view of that both parties agreed to digitize the full collection for the interest of community of scholars. The Suri Vidyasagar College and CSSSC both joined hand to achieve the goal.
- The CSSSC will prepare five sets of archive copy and two sets of access copy. The CSSSC will store the archive copy for safekeeping and the access copy will be shared between these two organizations for providing access to users.
- At the time of digitization the College library will extend all facilities to the archive staff of CSSSC assigned for the duty within the specified space of the library and deploy one staff to cooperate with the digitization team of the CSSSC.
- All costs directly associated with digitization and transportation of equipments and staff will be taken care by the CSSSC from one of its earmarked project accounts, most likely the Modern Endangered Archives Program (MEAP).
- The Suri Vidyasagar College will remain sole owner of rights of the documents and any form of reproduction for commercial use of any of the digitized documents will be determined by them only. However, the College is expected to allow unrestricted open access for all documents digitized under the project through servers of the institution itself and their partner institutions, such as the British Library, UCLA Library, Center for Research Libraries, Chicago, University of Heidelberg and the National Digital Library of India. The Suri Vidyasagar College may also make the documents accessible through their own networks, such as West Bengal Public Library or any other channels without any charges and fees for accessing. Both parties are agreeable on the policy of distribution of all historical works following the license agreement of Creative Commons (CC2).
- On completion of work, the CSSSC will hand over a set of access copy and a set of archive copy to the Suri Vidyasagar College for reading and redistribution of digital documents.

On this day of 6th January, 2022, both parties joined hand for the collaborative project to serve mutual interest of both institutions and the scholarly community in general.

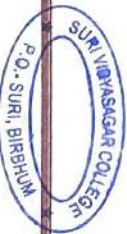

Sponsored undergraduate degree (PG in Zoology) College with its office at P.O.- Suri, District – Birbhum, West Bengal (India), Pin – 731101, established in 1942 affiliated to the University of Burdwan, hereinafter referred to as Suri Vidyasagar College and represented by its Principal, referred to as SECOND PARTY,

The aforesaid institutions are hereinafter referred to individually/ collectively as college/ colleges

PREAMBLE

Whereas, Turku Hansda Lapsa Hemram Mahavidyalay and Suri Vidyasagar College have many areas of common interest in Arts, considerable advantage may be gained from their pursuit of academic excellence on a collaborative basis in the fields of academics, pedagogy and research.

Now therefore, Turku Hansda Lapsa Hemram Mahavidyalay and Suri Vidyasagar College have decided to enter into this Memorandum of Understanding (hereinafter referred to as MoU), which defines the framework for the cooperation of the two institutions in the following sections.

ARTICLE 1: OBJECTIVES

Both colleges agree to develop the following collaborative activities in the academic areas of mutual interest, on the basis of equality and reciprocity.

The two institutions shall seek to promote:

A. Faculty exchanges

- i) Each institution will promote the exchange of faculty as well as to conduct special class in blended mode for the common UG Honours & Programme Courses.
- ii) Faculty exchange for the mutual benefit of both the institutions.
- iii) Collaboration in teaching, research and development, and consultancy studies in the field of mutual interest.
- iv) Conducting lectures

- v) Exchange of academic materials and publications
- vi) Undertaking joint research wherever feasible
- vii) Organizing and participating in seminars, workshops, symposia, other kinds of academic discussions,
- viii) Conducting study tours and joint consultancy work wherever feasible
- ix) Each Teacher will be responsible for his / her own transportation and daily allowances to and from the host institution.
- x) To use library reading room facilities for a specified period.
- xi) To use laboratory facilities in specific cases (with prior approval of Principal) for a limited period.

A specific plan will be worked out for each activity and detailed arrangements for such collaborative work will be agreed upon.

Turku Hansda Lapsa Hemram Mahavidyalay and Suri Vidyasagar College agree that detailed terms and conditions that guide each activity identified above will be determined separately and agreed upon by the two colleges. These terms will include a technical description of the proposed activity, financial arrangements and person(s) responsible for its implementation.

ARTICLE 2: COORDINATION

Each college shall appoint one member of its teaching faculty to coordinate the programme on behalf of the Principal of each college. Further, a Coordination Committee consisting of two Principals and the two coordinators will periodically (once or twice a year) review and identify ways to strengthen cooperation between two colleges.

ARTICLE 3: CONFIDENTIAL INFORMATION

The two colleges will retain and respect individual confidentiality, including those pertaining to the collaborative activities of both colleges.

ARTICLE 4: INTELLECTUAL PROPERTY RIGHTS

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software and any other industrial or intellectual property rights) developed jointly during the course of this MoU shall be vested in both the colleges in this MoU. Both the colleges shall have right to determine the commercial implications, disposition and exploitation of such intellectual property and shall make joint applications for the registration of the same. Any publication regarding such intellectual property shall be possible with prior written consent of both colleges.

C) Location of Academic Activities


